The "reference" guide rates were published with D.A. n.57 on 18.09.2012 and after exactly one decade, the F.G.S. with the Associations referred to below, ask that they be adapted to the current economic situation.

The request for publication in GURS was sent to the Regional Department of Tourism on April 8, 2022, as provided for in Article 10 of Regional Law No. 8 of May 3, 2004 and to be applied in 2023/2024

Base rate from 1 to 50 people

- Half a day (max 2 consecutive hours) € 140,00
- Half a day (max 4 consecutive hours) € 165,00
- Half a day (max 5 consecutive hours) € 200,00
- Full day (max 7 consecutive hours) € 240,00€
- Full day (max 8 consecutive hours) € 265,00€
- Supplement for each additional person (whole day) € 2,00
- Supplement for each additional person (half a day) € 1,50
- Supplement for each hour of extra service € 35,00
- Surcharge for night service (from 22:00 to 7:00) surcharge 35,00€

For services performed in several languages

20% surcharge on the base rate for the second language

40% surcharge on the base rate for the third language

50% surcharge on the base rate for the fourth language

100% surcharge on the base rate for the fifth language

Festive supplement

30% increase on the base rate for services performed on public holidays, excluding Sundays such as 1 and 6 January, Easter and Easter Monday, April 25, May 1, June 2, August 15, November 1, 8, 25, December 26.



Notes

- a) For full-day services, including meals and overnight stays, the tour guide travels at the expense of the group; if the guide is booked for the entire day (8 consecutive hours) and the group interrupts the visit for the lunch break, for each hour exceeding 8 hours, it should be considered as extraordinary. If ever the guide for the completion of the itinerary is forced to travel with its own vehicle, the fuel costs are borne by the group (fuel supplement: € 20.00 half a day, € 30.00 full day). Tariffs are considered to be of reference, in addition to legal charges if due;
- b) Last minute cancellations: in the event that the service is canceled by the customer 3 days before, 50% of the fee is due; if it is canceled within the previous 24 hours, 100% of the full amount is due.
